## Allegheny River\*\*

### **Robert Clemente Bridge/Sixth Street Bridge (0.6):**

A containment system is installed below low steel and follows the contour of the bridge. Vertical clearance is reduced **approximately 1-foot for the middle, 100 feet of the navigation span**. A work barge will be located outside of the navigation channel and will not affect navigation. Mariners are advised to transit the bridge with extreme caution. LNM 38-22

### **Karns Island Upper Light (27.4):**

The Coast Guard is proposing the following Aid to Navigation change: Discontinue Karns Island Upper Light (LLNR-280) at mile 27.4, Right Descending Bank, in approximate position 40-39-09.171N 079-41-32.511W. ## Ohio River\*\*

### **10<sup>th</sup> Street Wheeling Highway Bridge/Wheeling Suspension Bridge (90.3):**

Bridge Maintenance continuing through June 2023, the vertical clearance may **be reduced by 2 feet** due to maintenance being performed on the bridge. ### **Aid To Navigation (9.4):**

A nun buoy has been reported missing near Neville Island Back Channel, at Mile 9.4. The nun buoy will be replaced when weather and operations permit. Mariners are urged to transit this area with caution. LNM 09-23

A red bouy has been reported missing near Lower Sister Island, Ohio River, at Mile 85.7. Mariners are urged to transit with caution. BNM 0141-23

A green bouy has been reported off station at Georgetown Island, Ohio River, at Mile 37.7. Mariners are advised to transit the area with caution. BNM 0140-23

## Monongahela River\*\*

### **Smithfield Street Bridge (0.8):**

A containment system is installed and **will hang approximately 1.5 feet, below low steel**, following the contour of the bridge. LNM 33-22

### **Aid To Navigation (41.5):**

A nun buoy has been reported off station in the vicinity of Mile 41.5, near the lower gate, at L/D 4. Mariners are urged to exercise caution in the area. LNM 07-23
