## Port of Pittsburgh Commission Report

Mary Ann Bucci covered the following information:

- On behalf of the PMC Holiday Party Committee, special thanks were offered to all the companies that participated in the event and provided a record setting number of donations for the Chinese Auction this year.
- An informational CMAQ meeting will be scheduled for the week of January 12<sup>th</sup> to review submission & payment procedures along with funding availability. Information on the meeting will be sent out next week.
- The House passed a bill, "Achieving a Better Life Experience" (ABLE Act). The bill includes a 9-cent-per-gallon increase to the barge diesel user fee. Senator Bob Casey is introducing the bill in the Senate. The bill has 76-co-sponsors and is expected to pass. This is extremely positive progress for the replenishment of the Waterways Trust Fund.

### **Education Committee Report**

Michael Graham reported on the following:

- The spring "Who Works the Rivers" program will be held on April 16, 2015. It will host the Consortium for Public Education and the TFIM (the future is mine) group and total number of students should exceed 60 in attendance. ### **Navigation Committee Report**

Eunice Ratcliff reported on the following:

- In a proactive effort, Ice Committee conference calls are occurring between the US Coast Guard, Army Corp of Engineers, the National Weather Service and the Waterways Association of Pittsburgh Navigation Committee on a weekly basis.
- The Pittsburgh Area simulation is nearly complete in Paducah. Ingram Barge Company has provided Captains to run test simulations to work out the systematic details. The lower Allegheny River, Lower Monongahela River, and the Upper Ohio Rivers will be available. Campbell Transportation Company has been a huge sponsor of the project. Peter Stephaich is being honored at the Annual Riverbell Luncheon in Paducah and is receiving a Lifetime Achievement Award.
