Bridge Lights Extinguished:

*The Coast Guard has been notified that the following navigation lights are extinguished:*

***Donora Webster Bridge Mile 36.3***

- 1. Green Channel lights in both directions*
- 2. Both Red Pier lights up bound*
- 3. Left descending Pier Red light*

***Brownsville High Level Bridge Mile 55.9***

- 1. Right Descending Pier Lower Red Light up bound*

***Brownsville Highway Bridge Mile 56.2***

- 1. Green Light in both directions*
- 2. Left Descending Red Pier lights are out.*
- 3. Right Descending Red Pier light out on down bound*

USCG Broadcast Notice to Mariners:

*Western rivers Broadcast Notice to Mariners 0727-12 Ohio River, Coast Guard Sector Ohio Valley has received a report of diving operations being conducted at Mile Marker 8 OHR LDB. All vessels are requested to proceed this area with caution.*

*Western rivers Broadcast Notice to Mariners 0736-12 Ohio River, The East Liverpool waterworks intake pier light at Mile Marker 40.2 OHR (LLNR 23170) is reported extinguished. All mariners are requested to use caution while transiting this area.*

USCG Safety Zone:

***Allegheny River Mile 0.6 to 0.8 (Full river closure):***

*The Coast Guard hereby gives notice that the Captain of the Port Pittsburgh has established a temporary safety zone for the Light Up Night fireworks display from mile 0.6 to mile 0.8 on the Allegheny River, extending the entire width of the river. Persons and vessels shall not enter into, depart from, or move within this safety zone unless specifically authorized by the Captain of the Port Pittsburgh or her authorized representative. All concerned traffic can contact the Coast Guard on VHF-FM Channel 16 or the Captain of the Port at 412-644-5808. The safety zone will enter into effect at 9:00 pm until 10:30 pm on Friday, November 16, 2012.*

**Ohio River Mile 0.0 to 0.1 (Partial river closure):**

*The Coast Guard hereby gives notice that the Captain of the Port Pittsburgh has established a temporary safety zone near mile 0.0 on the Ohio River for the Santa Spectacular Barge Based Fireworks Display. The safety zone will encompass a 500 feet radius around the fireworks barge that will be positioned off The Point. Persons and vessels shall not enter into, depart from, or move within this safety zone unless specifically authorized by the Captain of the Port Pittsburgh or her authorized representative. All concerned traffic can contact the Coast Guard on VHF-FM Channel 16 or the Captain of the Port at 412-644-5808. The safety zone will enter into effect at 8:15 pm until 9:35 pm on Friday, November 16, 2012.*

**November 18, 2012**

**Allegheny River Mile 0.12 to Ohio River Mile 0.12 (Full river closure):**

*The Coast Guard hereby gives notice that the Captain of the Port Pittsburgh has established a temporary safety zone for the Pittsburgh Steelers Fireworks Display from mile 0.12 on the Ohio River to mile 0.12 on the Allegheny River, extending the entire width of the Allegheny and a small portion of the Ohio River. Persons and vessels shall not enter into, depart from, or move within this safety zone unless specifically authorized by the Captain of the Port Pittsburgh or her authorized representative. All concerned traffic can contact the Coast Guard on VHF-FM Channel 16 or the Captain of the Port at 412-644-5808. The safety zone will enter into effect at 7:30 pm until 8:50 pm on Sunday, November 18, 2012.*
